Subject: - BLACKLISTING OF FIRM M/S. ASIF & SONS LAHORE ON NON-COMPLIANCE OF CONTRACTUAL OBLIGATIONS

FOR THE WORK OF CONSTRUCTION OF TOWER PILE FOUNDATIONS / ERECTION & STRINGING FOR UP GRADATION OF 132 KV SDT T/LINE FROM BHUMB - KOT SHAKIR LOCATION NO. 63A & 64 AT RIVER JEHLUM CROSSING (EMERGENCY WOK)

The subjected work for construction of 02-No. tower pile foundations along-with erection & stringing was awarded to your firm M/s. Asif & Sons Lahore at 46.94% above the BOQ cost (Unit rate basis) with total amount of Project Rs. 40,424,969/- vide this office work order No. 2222 dated 26.11.2021 but you failed to complete the work in stipulated period, even after elapse of more than 250-days beyond the contract period. Although it was an *operational emergency* but your firm de-mobilized from the site without completing your contractual obligations, causing huge technical as well as financial loss to nation. This action created a bad name for FESCO. You were requested through numerous letter / reminders / meetings and requests by the FESCO to start and complete the work but you failed to complete the said work.

Consequently, after the approval of Competent Authority of FESCO, the contract was terminated and communicated to you vide this office letter No. 9336 dated 19.12.2022. Similarly, Pakistan Engineering Council (PEC) has also been approached for blacklisting of your firm M/s. Asif & Sons Lahore vide this office letter No. 9389 dated 23.12.2022.
