

# **FESCO INTERNSHIP**

## **EXTENSION IN LAST DATE TO APPLY AND PROVIDE MISSING DOCUMENTS**

It is notified for information that competent authority FESCO has approved to extend due date up to **30.06.2024** to apply for paid internship in FESCO for fresh candidates and provide missing documents in respect of existing candidates.

### **HOW TO APPLY**

The aspirants Graduates are required to get the nominations / recommendations (supported by CNIC, Picture, Domicile, Educational Documents from Matriculation to last Degree duly mentioning percentage of marks) from their Universities / Institutes and send it to **DG HR FESCO West Canal Road Abdullahpur Faisalabad** by courier on or before **30.06.2024** for internship in FESCO in following disciplines. **The candidates who have already applied are not required to apply afresh however, if certain documents are missing, they are directed to provide the same:-**

i.	Engineering	BSc Electrical / Electronics / Civil Engineering, having minimum <b><u>60% Marks / First Division</u></b> . PEC Registration is must.
ii.	Human Resource	BBA / BS (Business / Public Administration) (16- years education) / MBA / MPA having minimum <b><u>60% marks</u></b> .
iii.	Finance	BBA / BS (Audit & Finance) (16- years education) / MBA / Master Degree in Finance having minimum <b><u>60% marks</u></b> or <b><u>ACCA/ ICMA / CA (Finalist)</u></b> .
iv.	Audit	BBA / BS (Audit & Finance) (16- years education) / M.Com / MBA having minimum <b><u>70% marks</u></b> or <b><u>ACCA/ICMA/CA (Finalist)</u></b> .
v.	Information Technology	BS (CS) / BS (IT) (16- years education) / Master Degree in Computer Science having minimum <b><u>60% marks</u></b> .
vi.	Legal	Bachelor of Laws (LLB) or Master of Laws (LLM) having minimum <b><u>60% marks</u></b> .
<ul style="list-style-type: none"><li>• <b><u>M.S / MPhil Degree Holder will be given preference.</u></b></li><li>• <b><u>Result awaiting candidates are not eligible.</u></b></li></ul>		

### **PROVISION OF MISSING DOCUMENTS**

List of candidates who have already applied for internship, duly mentioning the detail of missing documents against each has been uploaded on FESCO Website. Such candidates are directed to provide the same before last date **30.06.2024**. In case of non-provision of any requisite document, their candidature shall be rejected and no claim whatsoever will be accepted nor any further extension in due date will be granted.

### **REQUISITE / MANDATORY DOCUMENTS**

- **Recommendation Letter from University / Institute.**
- Educational Documents from Matriculation to last Degree duly mentioning percentage of marks) for calculating the merit.
- CNIC, Picture and Domicile.
- PEC / PBC if applicable

The selection of interns shall be made strictly in the light of approved criteria / policy of BOD FESCO.
