- Sealed tenders are hereby invited from Courier Companies/Firms who are interested in distribution of electricity bills in the entire jurisdiction of above Divisions under Superintending Engineer (O) 1<sup>st</sup> Circle FESCO Faisalabad for the period of one year (extended upto three year on same terms and conditions if mutually agreed).

- The interested firms should provide the following detail 3 days prior to tender opening to this office:-
  - **Company profile.**
  - **One year experience certificates issued by contract awarding officers for disco, sui gas and Wasa utility bills distribution.**
  - **Manpower details with experience and academic details of Key personnel**
  - **Original Bank statement of last two years.**
  - **Certificate of financial soundness at least three million of balance sheet.**
  - **Complete address of office located in Faisalabad.**
  - **NTN certificate**
- Tender documents can be obtained from the office of Superintending Engineer (O) 1<sup>st</sup> Circle FESCO Faisalabad upto dates mentioned above on payment of Rs. **3000/-** (non-refundable) in any working day during office hours.
- Tenders can be submitted in sealed envelope on the scheduled dates and time and will be opened in the office of SE Operation 1<sup>st</sup> Circle FESCO Faisalabad on same date and time in the presence of contractor/firm or their authorized representatives.
- Conditional tenders will not be accepted/entertained.
- Distribution of electricity bills is required for aforesaid Sub Divisions under the jurisdiction of FESCO 1<sup>st</sup> Circle FESCO Faisalabad.
- Bidders will enclose a call deposit of Rs. **500,000/- (Refundable to un-successful bidders)** with their bid.
- Bidders will provide bill distribution experience certificate, if any.
- Successful bidder shall deposit surety bond/bank guarantee/performance guarantee @ Rs. 200,000/- per Sub Division issued by a scheduled bank in Pakistan.
- **All the taxes implemented by the Government will be deducted from the contractor's bills.**
