

PRE-QUALIFICATION OF CONSULTANTS/EXPRESSION OF INTEREST (EOI).

1. FESCO invites Expressions of Interest (EOI) for providing consultancy services for System Augmentation Program, MDGs, SDGs / SAP (DOP/ ELR) & Deposit Works and Village/ Rural Electrification projects.
2. Following are the major components of the said projects.
 - a) Technical and Financial Review and vetting of estimates prepared by Client.
 - b) Control of issuance of material to the contractors as per estimates.
 - c) Verification of materials installed at site and preparation of re conciliation statements.
 - d) Monitoring of construction works with reference to the specification and standards laid down by the client.
