2. FESCO invites sealed bids on **percentage basis** (**Above / below**) **on estimated amount**, under Single Stage-Single Envelope bidding procedure, from eligible firms under **National Competitive Bidding** (NCB) basis in accordance with Provisions of PPRA Rules.

## **ELIGITBILITY**

3. This Invitation for Bids is open to all Bidders meeting the following requirements:-

Written request accompanied with attested copies of: -

- a. Pakistan Engineering Council Certificate renewed for the <u>year 2024-25</u> with Category having Specialization Code as mentioned against above must be provided.
- b. The bidder shall be in the active tax payer list (ATL), and will provide income Tax Returns for last three years.
- **c.** The contractors are required to submit their registration for sales tax with Punjab Revenue Authority.
- d. Identity Card of Contractor / Managing Partner / Director of the firm.
- **e.** Bidding documents will be issued only to the owner / Managing Partner / Director of the firm.
- f. The bidder must have completed at least two contracts of same nature along-with its completion successfully as main contractor within Ten years awarded by WAPDA / NTDC / DISCO's.
- g. The consolidated value of these contracts <u>must be more than</u> 40% of the <u>estimated / B.O.Q Cost.</u>
- h. The bidder should have an **Average Annual Turnover two times of the amount** mentioned against this work during last three years certified from audited financial statement.
- i. Bidder shall demonstrate **Cash or Cash Equivalents equal to 20% of contract value** and current contract commitments. In this regard bidder shall provide the bank statements of last one (01) year.

- j. Bids will be evaluated by the Evaluation Committee in accordance with the tender conditions in bidding documents & PPRA Rules. Detailed assessment and progress of already awarded contracts and anticipated contracts to each contractor who is participating in the current tender must be carried out.
- k. All safety instructions narrated in NEPRA Safety Code must be adopted in true letter and spirit
- I. The contractor will submit separate application for issuance of each tender with relevant documents.

- 5. A complete set of Bidding Documents may be purchased by any interested bidder, meeting with the eligibility / qualification criteria, on submission of a written application to the above office and upon payment of a non-refundable fee **Rs. 3000/- (Three Thousand Rupees) each tender.**
- 6. All bids must be accompanied by a Bid Security amounting to **5% on BOQ amount** each in favor of **Executive Engineer (Civil) Civil Works Division-II FESCO Faisalabad** of any scheduled bank of Pakistan and shall be valid 28 days beyond bid validity. The bid shall be valid for 150 Days.
- 7. The bids will be opened at the office of **Superintending Engineer (Civil) FESCO**, **Faisalabad** in the presence of bidder's authorized representatives who choose to attend the tender.
- 8. Tender documents should be signed as per general directions given in the tender documents.
- 9. No rebate on tender rates will be acceptable.
- 10. All the procurement will be done according to PPRA Rules-2004 amendment up-to 2022.
- 11. Conditional / Electronic Bid shall not be permitted.
- 12. The bids covering partial and incomplete work shall be rejected.
