1. **CHIEF ENGINEER (OP) FESCO, FAISALABAD INTENDS TO INVITE BIDDERS FOR THE FOLLOWING TENDER: -**

2. FESCO invites sealed bids on **percentage basis (Above / below) on estimated amount**, under Single Stage-Single Envelope bidding procedure, from eligible firms under **National Competitive Bidding (NCB)** basis in accordance with Provisions of PPRA Rules.

ELIGIBILITY

3. This Invitation for Bids is open to all Bidders meeting the following requirements: -

Written request accompanied with attested copies of: -

- Pakistan Engineering Council Certificate renewed for the **year 2023-24** with Category having Specialization Code as mentioned against above must be provided.
 - The contractors are required to submit their registration for sales tax with Punjab Revenue Authority.
 - Identity Card of Contractor / Managing Partner / Director of the firm.
 - Bidding documents will be issued only to the owner of the firm OR representative holding Authority letter of the firm.
 - The application for purchase of bidding documents must be accompanied by a bid security amounting to 3% of the estimated amount/BOQ amount in favour of Executive Engineer (Civil) Civil works Division No. 1 FESCO of any Scheduled Bank of Pakistan and shall be valid 28 days beyond bid validity. The bid shall be valid for 150 days.
- Eligible Bidders may obtain further information, inspect and acquire the Bidding Documents from the Office of **Executive Engineer (Civil) Civil works Division-I FESCO, Faisalabad up-to 27-06-2024**.
 - A complete set of Bidding Documents may be purchased by any interested bidder, meeting with the eligibility / qualification criteria, on submission of a written application to the above office and upon payment of a non-refundable fee of **Rs. 10,000/ (Rupees Ten Thousand Only)**.
 - The bids will be opened at the office of **Executive Engineer (Civil) Civil works Division-I FESCO, Faisalabad** in the presence of bidders/bidder's authorized representatives who choose to attend the tender.
 - The bidder must submit atleast two work orders of building works of similar work cost or above executed during last five years .
 - Tenders documents should be signed as per general directions given in the tender documents.
 - Fresh Bank statement issued within week time before submission date of bid shall demonstrate closing balance not less than 50% of estimated cost of work.
 - Conditional Bid shall not be permitted.
 - All the procurement will be done according to PPRA Rules
