- The firms must provide original Certificate of performance and certificate of non-black listing and debarring duly issued by respective Employer.
- The firms who have been issued three warnings by the Employer i.e., WAPDA / PPMC/ DISCOs / NTDC / FESCO for non-completion of any work orders within stipulated time are not eligible to apply.
- The interested firms / company should be NTN holder & registered with FBR, PRA & SECP.
- Summarize actual assets and liabilities for the previous five years alongwith audit reports.
