## ELIGITBILITY

- This Invitation for Bids is open to all Bidders meeting the following requirements: Written request accompanied with attested copies of:
  - a) Pakistan Engineering Council Certificate renewed for the <u>year 2024-25</u> with Category having Specialization Code as mentioned against above must be provided.
  - b) The bidder shall be in the active tax payer list (ATL), and will provide income Tax Returns for last three years.
  - c) The contractors are required to submit their registration for sales tax with Punjab Revenue Authority.
  - d) Identity Card of Contractor / Managing Partner / Director of the firm.
  - e) Bidding documents will be issued only to the owner / Managing Partner / Director of the firm.
  - f) The bidder must have completed at least two contracts of same nature along-with its completion successfully as main contractor within Ten years awarded by.
  - g) The consolidated value of these contracts must be more than 40% of the estimated/B.O.Q Cost.
  - h) The bidder should have an Average Annual Turnover two times of the amount mentioned against this work during last three years certified from audited financial statement.
  - Bidder shall demonstrate Cash or Cash Equivalents equal to 20% of contract value and current contract commitments. In this regard bidder shall provide the bank statements of last one (01) year.
